
Month in Review


Nordic hedge funds lost an estimated 0.1% in October bringing the NHX Composite to a year-to-date performance of 2.9%.

In a volatile month, Managed Futures/CTA was the weakest performer following a period of very strong returns. Other strategy groups recorded small changes. Within strategy sub-categories, performance dispersion was on the high side as funds reacted differently to the sell-off in risk assets beginning of the month.

Sub-Strategy & Country-by-Country Performance

- The NHX Composite lost ground in October on the back of losses seen in Managed Futures (-1.0%) and Fixed Income (-0.2%) strategies.
- NHX Fixed Income is the best performing strategy on the year (+4.4%) and all NHX sub-categories remain firmly in positive territory year-to-date.
- On a country-by-country level, Finland experienced the most significant losses (-1.7%) during the month. On the year, Denmark is now the best performing country (5.2%) followed by Finland and Sweden.
