

Greenspan: Disappointing hedge fund returns but no system threat

According to Federal Reserve Chairman Alan Greenspan, low long-term interest rates worldwide, directing capital to private equity and spurring hedge funds to seek out higher returns could result in losses and a “temporary shrinkage” in the hedge
