

Swedish hedge fund positioned for Sardus takeover

Swedish industry insiders are betting that Sardus, one of Scandinavia's largest luncheon foods manufacturers, is the subject of an eminent takeover. Hedge fund management company Prior & Nilsson has purchased 5% of the company.
