

# **Swedish pension fund AP1 leaves committee following Carnegie chairman dispute**

**Carnegie is in the process of acquiring a new chairman of the board following warnings by the Swedish FSA that it may lose its operating licence. In protest against the leading candidate, the Swedish pension fund AP1 has withdrawn**
