NHX Performance Review - July 2015


Month in Review

Nordic hedge funds gained an estimated 1.2 % in July, recovering from the losses experienced in June. Year-to-date, the NHX Composite stands at +4.4 %.


July saw all strategy subsets bouncing back with CTAs and Multi-Strategy funds gaining the most. CTAs profited from a continued sell off in commodity markets, most notably within metals and energies.

Sub-Strategy & Country-by-Country Performance

- The NHX Composite gained 1.2 % in July. CTAs (+1.6%) and Multi-Strategy funds (+1.5%) were the best performing strategy groups. Equity strategies (+1.3%), Fund of Funds (-+0.9%) and Fixed Income funds (+0.5%) also gained.
- On the year, NHX Equities is the best performing sub-category followed by NHX Multi-Strategy.



 On a country-by-country level, Finland is the best performer on the year. All countries gained on the month
