

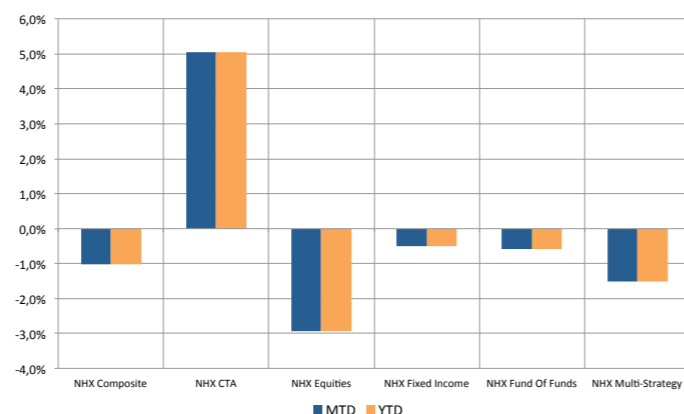
Month in Review

Nordic hedge funds lost an estimated 1.0 % in January 2016.

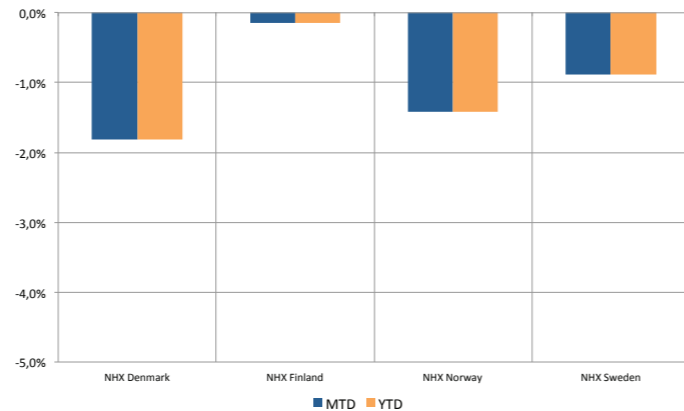
Managed Futures was the only category gaining on the month as trends in fixed income, equities and energies supported systematic momentum based strategies in particular. Equity strategies took the biggest hit given a deteriorating investor sentiment fueled by the oil glut and worries for a slowdown in the Chinese economy.

Sub-Strategy & Country-by-Country Performance

- The NHX Composite lost 1.0 % in January. All sub-categories except Managed Futures (+5.0%) was in the red. NHX Equities (-2.9%), NHX Multi-Strategy (-1.5%), NHX Fund of Funds (-0.6%) and NHX Fixed Income (-0.5%).



- On a country-by-country level, all countries recorded losses, Finland being the less hit given a high reliance on CTAs.
